Name, Address and Telephone Number of Applicant: United States of America, Department of the Interior. Bureau of Land Management, San Luis Valley Field Office 1313 Highway 160, Monte Vista, CO 81144. 2. Introduction and Background. The Bureau of Land Management (BLM) acquired the trans-basin Treasure Pass Diversion Ditch (ditch) and its associated water right in April 2019. BLM is simultaneously filing two water right applications to accomplish its management objectives for this ditch. In Water Division 3, BLM is filing an application to change the historic Treasure Pass Diversion Ditch water right to types of use and places of use that will support BLM's resource management objectives along with claiming appropriative rights of exchange. In Water Division 7, BLM is filing an application for a junior water right to be diverted at the ditch along with appropriative rights of exchange. The BLM is pursuing these dual applications because BLM has demands in excess of the historic Treasure Pass Diversion Ditch water right of 7 cubic feet per second (cfs). These demands are partially satisfied by diversions from the ditch under a junior water right. The historical diversion records for the ditch show frequent diversions in the range between 7 cfs and 13 cfs, demonstrating that there is physical capacity in the ditch above 7 cfs, and that diversions above 7 cfs were part of the historical operating practice. This application, which focuses on the change of the historical water right, addresses diversion diversions of up to 7 cfs that were made under the historical water right. The changed historical water right and the new junior water right will support wetlands habitat and wildlife management at BLM's Blanca Wetlands Area (Blanca Wetlands) and South San Luis Lakes Area (SSLA). To deliver the changed water right and new junior water right in the correct timing and amount to support wetland habitat and wildlife management objectives, the applications request water court confirmation of the storage and subsequent release of the changed historical water right and new junior water right for beneficial use. The reservoirs in which changed historical water right and junior water right will be stored include reservoirs owned and managed by Colorado Parks and Wildlife (CPW) and other reservoirs where BLM has agreements for storage space. 

AUTHORIZATION TO TRANSFER IMPACT FEE REVENUE TO MAIN ACCOUNT FOR ENGINEERING/STUDIES/SURVEYS EXPENDITURES FOR CAPITAL FACILITIES

WHEREAS, San Juan Water Conservancy District ("SJWCD" or "District") is a quasimunicipal corporation of the State of Colorado organized under §37-45-101 et seq. ("Act") which provides that it is to be governed by a Board of Directors appointed by the Archuleta County District Court; and

WHEREAS, the District has received revenue from the Town of Pagosa Springs impact fee pursuant to Town Ordinance Nos. 662 and 676 (series 2006; repealed by Ordinance No. 911, series 2019) and an Intergovernmental Agreement between the District and Town dated August 1, 2006 ("Impact Fee Revenue"); and

WHEREAS, the District holds \$16,474.86 in Impact Fee Revenue in a separate interest bearing account; and

WHEREAS, the District is authorized to spend the Impact Fee Revenue on capital facilities needed to serve new development, including for planning and preliminary engineering services associated with new or expanded water conservation and storage facilities;

WHEREAS, the District's budget for 2021 appropriated \$40,000.00 for "Engineering/Studies/ Surveys" and does not specify a source of the revenue for that appropriation;

WHEREAS, in 2020 and 2021 the District spent \$18,641.25 on the West Fork Water Rights Study by Wilson Water Group to complete planning and preliminary engineering services to determine whether the West Fork Reservoir and Canal water rights owned by the district can be used, in conjunction with its other water rights, to provide storage and diversion of water in new facilities; and

WHEREAS, the directors of the District have concluded that, based on the foregoing, the Impact Fee Revenue should be used to pay for the Wilson Water Group Study.

NOW THEREFORE, be it resolved by the SJWCD Board of Directors, that the Treasurer of the District shall transfer \$16,474.86 from the District's Impact Fee Revenue account to its main account to apply to the expenditure on the Wilson Water Group Study.

I. Overview of San Juan Water Conservancy District

The San Juan Water Conservancy District (SJWCD) was formed on October 22, 1987, as a duly organized water conservancy district pursuant to the Water Conservancy Act following approval by Archuleta County voters. The SJWCD is charged with providing water issues and conservation education, water resource planning, stream improvement, water rights protection, and development services within its service area, which is located wholly within Archuleta County along the headwaters of the Upper San Juan River.

In early 2021 the SJWCD published its Strategic Plan outlining the Strategic Objectives and associated actions required to accomplish these objectives. The Strategic Plan may be found on the SJWCD website at https://www.sjwcd.org. A key objective for 2021 involves communication and education of the community on water issues that impact the region (see Objective #2: "Education of the community at large regarding critical water issues that face the District, the Southwest Basin of Colorado, and the Colorado River Basin and its tributaries.")

In May 2021 members of the SJWCD Board participated with leaders of other community organizations in Pagosa Springs and Archuleta County in a workshop offered by the Sonoran Institute to assist communities in incorporating water considerations in their growth plans. Please see the Sonoran Institute website for more information on these Growing Water Smart workshops (https://resilientwest.org/2020/co-gws-rfa/). The Pagosa Springs/Archuleta County Growing Water Smart workshop team developed multiple objectives aimed at addressing water issues in the Upper San Juan River Basin. A key objective involves communication and education of the community on water issues that impact the region. As this objective meshes well with the SJWCD Strategic Plan objective on community education and communication, the SJWCD has agreed to consolidate, coordinate, and manage these education and communication efforts.

II. Overview of the Marketing Project

While the SJWCD and the Pagosa Springs/Archuleta County Growing Water Smart team have identified community education and communication on water issues as key objectives for 2021, there are numerous organizations (including town and county planning departments) with a similar focus on community outreach on water issues. The SJWCD and the Growing Water Smart teams wish to consolidate these outreach efforts in a coordinated program with consistent messaging. Development of this messaging will require assembling the various water stakeholder groups in what will likely be a series of interactive focus groups. With a consistent message developed, it is envisioned that citizen focus groups will be held to confirm that the message resonates within the community before launching a broad outreach program.

The community education and communication outreach program on water issues will include multiple avenues of engagement with the community including regular articles published in the local press, presentations at meetings of concerned local organizations, email campaigns, mass mailings of informational brochures, poster campaigns,

information on the websites of various concerned local organizations, etc. The SJWCD and the Growing Water Smart team desire to develop and execute a cost effective comprehensive marketing strategy and action plan that addresses the community outreach objective.

III. Details of RFP Parameters

(1) Marketing Strategy

The SJWCD seeks a vendor to develop a cost effective yet comprehensive marketing strategy (both digital marketing and traditional) that would utilize social media (e.g. Facebook, Instagram, YouTube, and Twitter) and other media as suggested (e.g., posters, direct mailings, press articles, ads, etc.).

Overall services are to include:

- (a) Development of digital and traditional marketing strategy with suggested budget expenditures;
- (b) Initial cost assessment, set-up, strategy, and support for postings and channel management with suggested resources;
- (c) Create and advise on an e-mail, social media, strategy (e.g. frequency of postings, suggested topics) with newsletter and blogging as appropriate to maximize outreach and connect with widest possible audience;
- (d) On-going support

It is requested that the vendor also include in the proposal response the cost of such ongoing support preferably in the form of an hourly rate and estimated monthly cost related to social media posts and regular (i.e., quarterly or as-needed) evaluation of the effectiveness of the strategy, to evaluate execution, and advise the SJWCD on strategy adjustments.

Timeline: The SJWCD envisions a timeframe for completion of strategy outline and framework within four (4) weeks of contract authorization.

(2) Development of Message

In addition to the SJWCD and the Pagosa Springs/Archuleta County Growing Water Smart team, there are numerous organizations with a focus on community education and communication outreach on water issues impacting the Upper San Juan River Basin. The SJWCD seeks a vendor to assist in the development of a consistent message agreeable to all (or most) such water stakeholders. It is envisioned that multiple meetings as focus groups will be required to develop this consistent message. The marketing consultant will then confirm that the messaging resonates within the community by holding a number (to be determined by the consultant) of community focus group sessions where water issues are discussed.

Timeline: The SJWCD envisions a timeframe for development of the messaging for the project within two (2) months of contract authorization.

(3) Education and Communication Material Development

A significant amount of education and informational materials addressing water issues is available through various organizations in Colorado. The marketing consultant will make use of these materials as possible and adapt for local use. The consultant will develop additional materials as necessary to fulfill the marketing strategy.

All text, graphics, video, source code, and editorial content created by the consultant in connection with the marketing strategy will become the sole property of the SJWCD and may be used for any purpose including but not limited to posting, disclosure, reproduction, broadcast, and transmission. The vendor shall covenant that any material published or technologies used in the project will not violate or infringe on any copyright, trademark, patent, statutory, common law or proprietary rights of others, or contain anything libelous or harmful.

Timeline: The SJWCD realizes that this is an on-going effort and would expect that initial copy and graphics to be reviewed would be available starting within one (1) month of the development of the messaging for the project and not more than three (3) months from contract authorization.

IV. RFP Evaluation Criteria

The minimum general proposal requirements include:

- (a) Qualifications and experience of the project team
- (b) Demonstrated understanding of scope of work and suggested approach to project
- (c) Artistry based on prior portfolio submitted with three (3) samples of prior projects
- (d) Capacity to perform work within schedule and budget
- (e) Billing rates, hourly, to remain in effect for the duration of the project
- (f) Any additional terms or conditions to which the parties may agree
- (g) Please provide three (3) references.

In-person or virtual meetings or conference calls may be requested of proposing vendors during the evaluation period.

Be advised that these are minimum requirements and the SJWCD is receptive to innovative ideas and value-added concepts provided in the proposal that will be considered and evaluated as part of the selection process.

V. Proposal Evaluation

Proposals will be evaluated by the Board of the SJWCD or a subset thereof. The SJWCD reserves the right to request additional information or clarification from a submitting vendor regarding the specifics of the proposal, negotiate modification, reject any and all proposals, and waive informalities or irregularities in a proposal, split or make the award in any manner most advantageous to the SJWCD at its sole and exclusive discretion. The SJWCD prefers that the project be led by one prime contractor providing a single point of contact and coordination with any other vendors.

VI. Submission of Proposal Requirements

(1) Summary Letter

Submission of the "Statement of Work" engagement letter will constitute a representation by your firm that your firm is willing and able to perform the commitments contained in the proposal. The letter must be signed by a person authorized by your firm to obligate your firm to perform the commitments contained in the proposal. The letter must also include a statement that your firm is able to comply with the contract requirements.

(2) Organization Identification

Provide, as applicable, the following information about the vendor's organization, company, partnership, coalition or unincorporated association:

- Vendor's Name
- Ownership structure
- Business Registration and Federal Identification Number (FIN)
- Name and telephone number of vendor and vendor's contact person.
- Brief biographies of team members with main point of contact indicated
- Number of years vendor has operated under this name
- Brief description of the nature of vendor's business
- Type of business organization
- Website address (if any)

(3) Qualifications and Experience of Project Team

- Identify the key personnel to be assigned to the project, including their key responsibilities
- Include a brief summary of each individual's qualifications and relevant experience
- Identify the proposed project manager who will be responsible for the day-today execution of the project and his/her relevant experience in leading similar efforts

(4) Previous Experience and References

Provide contact information including name, organization, address, phone number, and email, for at least three references for projects, preferably of a similar scope and size. For each reference, provide a brief summary of the nature of the work and the outcomes of the engagement.

(5) Schedule and Budget

Respondents should provide a hourly rate and an estimate of the total required time for the work to be done. Respondents should address whether the timelines presented in Section III (Details of RFP Parameters) can be met and if not, the expected timeline for each task. The anticipated total budget for this project is expected to be \$10,000 with the possibility of an expansion of the scope if additional funding is received. The project

is expected to be completed by the end of 2021. Again, an extension is possible if additional funding is received.

Be advised that separate reimbursement for travel related expenses is not included.

(6) Required SignatureA signed proposal must be included with your submission.
